## ***President's Letter: Preservation Equals Protection***

Bald Head Island is home to three diverse environments: the creek side marsh, the open dunes, and the maritime evergreen forest. It is this diversity that has played a role in the decision that many of us made when we initially invested in our property. Our wonderful island offers us an opportunity to feel a quiet serenity and a closeness with nature in very different environments.

All of us who purchased property in Stage I have legally agreed to adhere to the Bald Head Association Covenants. It is the responsibility of the BHA Board to enforce adherence, not only to these Covenants, but also to the Association's By-laws and the Design Guidelines. These important documents protect both property values and the natural resources within Stage I. Although they sometimes restrict what we do on our property, they also provide protection to us and to our neighbors.

Over the past few months, many property owners have expressed concerns about the cutting of trees and clearing of undergrowth. This has occurred both on private property and our common property.

I want to remind everyone of the rules as we clean up yards and improve our views. The 2016 Landscape Guidelines section of the Design Guidelines contains all the specific information property owners need when improving or maintaining their yards. The permissions needed are best summarized in this paragraph from the Design Guidelines:

“Village Ordinance provides that removal of any tree or trees 3 inches or greater in diameter at 48 inches above grade requires permission and/or a landscape permit from the Village Building Inspector,

even if the tree is determined to be dead or diseased. Per Village Ordinance, removal of branches of 5 inches or more in diameter also requires Village approval. ARC approval is required for the removal of trees 3 inches in diameter and understory vegetation 1 inch or greater in diameter measured 48” along the trunk from ground level, tree limbs of 3 inches or more in diameter and clustered growth vegetation two square feet or more at ground level regardless of branching habits or diameter.”

If you are not sure if permission is needed for the trimming, pruning and weeding that you plan to do, please call ARC Coordinator Karen Mosteller at the BHA at 910-457-4676 ext. 22. She will be happy to help you.

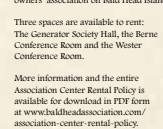

containers and access road to Public Works to continue providing service. As we work through the construction and permanent location of the Public Safety Complex over the next 12 months or more, there will be additional work in implementing a long-term layout of the Public Works and Contractor Services facilities to include new locations for the commingle recycle and cardboard containers.

**Public Safety Complex construction project & temporary relocation of recycle & cardboard containers:**

As was recently reported in a Village's Voice update on the Public Safety Complex construction project, that as part of the construction and location of the new Public Safety building there will be a need to temporarily relocate the commingle recycle containers and cardboard container from their current location. For reference, the map below shows the temporary location of the commingle containers being located adjacent to the Public Safety Administration Building on Edward Teach Wynd Extension.

The cardboard container will be temporarily relocated to a location in Contractor Services yard.



Additionally, the current access road to get to the Public Works facility from Edward Teach Wynd Extension, including the trash compactor for residents dumping trash, will be removed as that portion of the road is located within the building footprint of the new Public Safety building. A temporary access road is being constructed that will provide continued access for Public Works staff and residents needing to drop off trash at the compactor during normal business hours. the temporary access road through Contractor Services yard to Public Works.

Old Baldy 1968

Old Baldy is the oldest standing lighthouse in the State of North Carolina, the second of three lighthouses that stood on the island. It has maintained its original form and location for almost 200 years. The most important purpose of Old Baldy was to mark the Cape Fear River entrance for the maritime sailors. It was never intended as a light for Frying Pan Shoals. Old Baldy was built in 1817 of soft red bricks covered with stucco. In the early days the lighthouse keeper would white wash Old Baldy every two years. When Old Baldy was deactivated in 1935 the lighthouse was abandoned. The white wash protected the stucco. When it was discontinued large pieces of the stucco began to fall off the lighthouse. Occasionally someone would come along and patch the lighthouse with new stucco; however, they did not use the same stucco as was used in 1817. Today Old Baldy has a unique patch work look of different stuccos. In 1988, the historic light was relit but no longer serves as an “official” navigational aid.

In 1985 a group of dedicated individuals, both on island residents and off island lighthouse enthusiasts formed The Old Baldy Foundation, Inc. a 501(c)3 not-profit organization. The Old Baldy Lighthouse and surrounding grounds were deeded to the Old Baldy Foundation which has sole responsibility for the operation, maintenance and preservation of the Smith Island Museum and Old Baldy Lighthouse.

The Foundation is governed by a Board of Directors and operated by a staff of 5 along with many volunteers. A small museum, located in a replica of



the keeper’s cottage, currently offers exhibits, programs and events for visitors of all ages. In the future The Smith Island Museum will add a new gift shop/administration building, exhibit building for the Cape Fear Fresnel Lens, and renovate existing space in order to offer more exhibits, collections and living history experiences for visitors. The Smith Island Museum will collect, display and interpret artifacts and stories related to the past and current history of Bald Head Island and the Cape Fear Region. The Old Baldy Foundation continues in this role so as to preserve the historic educational and architectural value of the lighthouse and the man-made history of Smith Island in perpetuity.

**Why is Old Baldy Important?**

Lighthouses and the maritime heritage they represent are an important part of history, particularly along the Carolina coast where they have historically played a critical role in life and death.

Of the seven standing lighthouses in North Carolina today, Old Baldy is the oldest. During the Civil War, Old Baldy stood within the walls of Fort Holmes built by the Confederates in late 1863 and abandoned to the Union in early 1865. This fortification was named for the man who at one time commanded the Confederacy’s Southern Department of Coastal Defenses, Major General Theophilus Hunter Holmes. Extensive remnants of Fort Holmes are still visible on Bald Head, especially in the immediate vicinity of Old Baldy.

In addition, Old Baldy is significant for its

architectural design. It stands today as one of the best examples of the federal octagonal design. This design was only in use for approximately 15 years from 1789 - 1820. Another distinctive feature of Old Baldy's design is the off set lantern. The lantern and many of the bricks used in the construction of Old Baldy were salvaged from the first lighthouse built on Bald Head Island. This first Bald Head Island lighthouse was commissioned by Thomas Jefferson and was built in 1794. It became necessary to pull down this first lighthouse in 1813 due to erosion.

### **Old Baldy was listed on National Register of Historic Places in 1975.**

Every year thousands of people are drawn across the Cape Fear River to Bald Head Island. Once on island, they are drawn as if by magnetism to the Old Baldy Lighthouse. Children chant her name, "Old Baldy, Old Baldy" on the ferry, parents climb the 108 steps with their families year after year, brides and grooms promise their love to each other at her base and senior citizens unable to climb the lighthouse stand and stare at the 110 feet of bricks, mortar and history.

### **OLD BALDY MISSION & FUTURE:**

**Mission:** *The Old Baldy Foundation is a non-profit organization established for the preservation of Old Baldy Lighthouse on Bald Head Island, NC and for the promotion of and education about the man-made histories of Smith Island.*

### **Old Baldy's Future**

The Old Baldy Foundation is financially viable. The Foundation currently relies on a number of fundraising events throughout the year as well as private corporate and individual donations and revenue from operations. The lighthouse and museum sees nearly 30,000 paid visitors annually while our Gift Shop grosses about \$160,000 a year. Most years the Foundation finishes in the black allowing us to keep funds in reserve for major repairs and capital improvement projects.

Structurally the lighthouse is in good condition because of the Foundation's dedication to its ongoing maintenance. A \$125,000 repair project for the lantern room is being executed since the Fall of

2016. It is the intention of the Foundation's Board that the Old Baldy Lighthouse and museum continues to be an affordable and accessible destination for visitors.

The Old Baldy Lighthouse and museum complex which includes the Keepers cottage (Smith Island Museum), Old Baldy Lighthouse and the Oil House, is slowly becoming overburdened with the increase in visitors, programs and activities. The Old Baldy Foundation has expanded its educational outreach to audiences both on and off the island. Specifically tailored programs, tours, lectures and publications are offered by staff and volunteers to diverse audiences ranging from families and children to adults and special interest groups. Additionally, we acquired the 1903 Cape Fear Lighthouse First Order Fresnel Lens, and the Foundation's collections have grown. A capital campaign began in 2016 to raise the necessary funds to expand the campus to include a new Interpretive Center/ gallery building.

This year we are celebrating Old Baldy's 200<sup>th</sup> birthday with monthly events focused on the history of Old Baldy and the Cape Fear region. The intent of all of these events is to raise awareness of the important task of the preservation of our cultural and historic resources and to raise funds for the ongoing care of Old Baldy. ## *Fond memories...Stories from the past*

### *~ A letter to the editor from Watts Carr*

Jane,

Betsy and I started visiting BHI in the late 60's. We built our first house on Flycatcher Trail along with Genevieve (Gen) and Tom Cummings in 1982, and moved it to Stede Bonnet due to erosion in 1989, sold it in 1991 and built our own current home on Cape Fear Trail in 1992-3. There are many Bald Head Island stories we could tell and maybe some would be interesting to others?

In 1968, the conservationist/developer Charles Fraser seriously wanted to acquire and develop BHI in the same vein as his noted low key development on Hilton Head Island (HH WAS low key in 1968). I was a banker in Durham at the time, had visited Sea Pines on Hilton Head (HH), SC, and could easily see the demand for a similar development in North Carolina with Bald Head Island (BHI) being the only logical property. Betsy and I contacted Fraser about my interest in his BHI intentions and we soon were invited down for a three-night visit with Fraser and key HH staff. It was a terrific visit and Fraser suggested a position for me down there at Hilton Head because North Carolina's Governor (Bob Scott) and conservationists, who were opposed to the development of BHI, had cooled Fraser's interest in the NC island with numerous anti-development actions and strong words. We decided to sit tight at the bank. That changed in 1970 however and we moved to Rockingham County, with a start-up textile

firm, but kept an eye on developmental planning for BHI. Strangely enough, just before leaving the bank Betsy ran into a Wake Forest College friend, Robert Boone, and he told us that William "Bill" Henderson was going to be in Durham THAT night to make a presentation to potential investors in the Carolina Cape Fear Corporation and that we should attend since we were interested in BHI. We did, and our serious connections to BHI really began that very night.

Jane, there's a lot to tell, like the night in 1970 we spent in Capt. Charlie's cottages with Gen and Tom Cummings, watching the snow fall as we jeeped out to those three buildings after being dropped at the creek landing by Charlie Swan and then almost burning the cottage down while charcoaling on the wooden porch. We were probably the only people on the entire island that night and the next! And then meeting the next early afternoon three subsequent island legends, Thad Wester and Bill Berne who were being shown around the island by John Messick!

Jane, BHI has meant SO much to our family for almost 50 years, and while we surely appreciate the conveniences of the Maritime Market, the efficient tram and ferry service, Mojo's and Delphina's, consistent power, FIRE/EMT's, the Conservancy, our clubs, cable TV, our Village Chapel and other now-standard amenities, we do sometimes fondly recall the earlier and quieter days with CB radios and Sunday Communion on the Saturday night bar at the long-since-gone BHI Inn. I have to add that we travel a good bit, frequently cruise, but we so often find ourselves on these grand trips wondering why we would ever want to be "wherever" instead of back on our BHI porch watching a Hanjin come upriver, or porpoises bobbing along our beach, or thirty pelicans diving for dinner out front, or another majestic sunset, and then we remind ourselves just how lucky we Bald Head Islanders truly are!

### The Old Quarantine Station

Ever wonder what the concrete slab was for that you pass leaving Deep Point on the Ferry while heading to Bald Head Island?

It is all that is left of the quarantine station built to fumigate ships coming from foreign ports to stop the spread of deadly epidemics.

In 1868, the state General Assembly authorized a quarantine station at Smithville.

Yellow fever and cholera were sometimes brought ashore by infected sailors or passengers from ships, which had traveled to South America and the Caribbean. Wilmington had yellow fever outbreaks in 1819 and 1821. The great yellow fever epidemic of 1862 — which killed at least 600 people and sent thousands more fleeing the city — was blamed on a blockade-runner.

The quarantine station burned down in 1882, after which locals lobbied to have a replacement moved farther away from town. In 1893, the General

Assembly voted \$20,000 to have a new quarantine station built. The new facility was completed in 1897.

The new station was finally located about a mile upriver from Southport, across from the Price's Creek Lighthouse. An artesian well was dug for the facility in 1897. In 1901, quarters were added for detained sailors. A hospital building followed in 1904, an additional wharf in 1914, a water tower in 1920 and a launch shelter in 1921.

According to a 1907 report, the station passed 86

vessels, 19 steamers and 11 sailing ships. Two steamers and three sailing ships were disinfected, and a total of 610 crew members and three passengers were disinfected.

By the 1930s, new international public health laws and a system of bills of health had rendered the Southport quarantine station out of date. In 1937, it was put on surplus status, under the care of a custodian. In 1946, however, it was turned into a relief station.

The old quarantine station burned to the ground in 1953. After Hurricane Hazel in 1954, only a concrete slab that supported the watertower was left of the old complex.


