President's Letter: Trust

This past week I attended (only!) two Association meetings on Bald Head. Both were lengthy, but productive. In each it occurred to me that there exists an underlying current based on

trust. A few examples follow.

One of the key roles of the Bald Head Association is advocacy, particularly for second homeowners. Elections and property taxes affect all island owners, but only permanent residents and others who are registered to vote on Bald Head have a voice in decisions that affect us all. The Association's focus on flood insurance, which will continue to affect second homeowners more

profoundly than primary residents, is an example of the Association addressing the needs of all its constituents through advocacy. Hopefully all of our property owners trust that the Association will always remain vigilant in identifying, communicating and advocating for issues that affect them.

In May registered island voters will have a say on the proposed \$18 million Village referendum for the installation of a terminal groin at the river mouth at the convergence of South and West beaches. Only those registered to vote and actually voting will determine if this structure will be built. Second homeowners must trust that their interests will be represented. (Read more about the terminal groin inside this issue.) At its April meeting, the BHA Board voted on behalf of all its members to encourage eligible islanders to vote FOR the terminal groin.

There is no doubt that this is a unique window of opportunity to try something different at Bald Head and in the state of North Carolina. Will the terminal groin work to capture sand drifting into the

channel along South beach?
We must trust the incredibly complicated work done by our elected Council, its committees, volunteers and specialists. Will this effort save islanders from more frequent and costly beach renourishment? We must believe those whom we have entrusted to develop this plan to improve the long-term health of our beaches at a cost that is affordable and sustainable.



Another issue relating


to trust that primarily affects second homeowners is home maintenance. Homeowners can leave a house key at the Association office for use by designated contractors to perform work on their homes in their absence. This involves completing a form available on the Association web site that lists those whom an owner approves to have access to his/her home and, of course, providing a key. This great convenience to property owners exists because of trust that the Association will keep keys securely and abide by

Controlling light makes a difference...

Most Bald Head islanders know the importance of being frugal with exterior lighting. Nesting female and hatchling loggerhead sea turtles should not be exposed to artificial sources of light while on BHI. The hatchling's very survival depends on this and it's recommended that all beach front homes install room darkening window treatments on windows that face the beach, and that blinds be closed from dusk to dawn during the turtle season (May 1st – November 15th) to prevent interior house lighting from disturbing the nesting and hatching of the sea turtles.

It's also important to note a couple of other negative costs associated with light pollution. First is the loss of the starry heavens. When we help to keep the sky dark, we regain the ability to see comets and falling stars and all the wonders in the sky that thrilled us as children. Secondly, who doesn't like to save money? By limiting the use of exterior lighting, we don't waste energy and we give nature the opportunity to light our path. At the very core of the ARC design guidelines is a philosophy of resource management. These values help to keep Bald Head Island's unique environment intact for future generations.

The most recent change to the lighting guidelines is the requirement to use warm white light defined as bulbs with a color temperature of 3200 degrees Kelvin or less. Keep in mind, even using the same wattage, a cool white light appears much, much brighter than a warm white because of how the eye sees that part of the spectrum. When purchasing bulbs, the words 'warm white' can usually be found on the front of the box and the color temperature listed in the fine print. For your reference, below are the current updated lighting guidelines. If you feel

ARC Design Guidelines (pages 19 & 20)

Exterior Lighting

<u>REQUIREMENTS</u>: Applies to new construction, renovations and complaints.

- 1. <u>Lighting</u> will be baffled to prevent direct visualization of the light source.
- 2. Exterior wall and exterior recessed lighting shall have a baffle-to-light-source relationship that creates a maximum of 90-degree spread of light from the bottom of the baffle. See diagram and examples of the baffle-to-light-source-relationship calculations below.
- 3. All pathway lighting shall have a baffle-to-light-source relationship that creates a maximum of 120-degree light spread from the bottom of the baffle. See diagram and examples of the baffle-to-light-source relationship calculations below. All pathway lighting shall be no higher than three foot from grade.
- 4. Bulbs will be from the white family and no bulb shall be greater than 60 watts incandescent equivalent (8 watts LED, 15 watts CFL). The bulb/light color temperature should be approximately 3200 degrees Kelvin or less, which is warm white in color.



- 1. The service is free but you must possess a Brunswick County Library card to participate. Visit a Brunswick County library branch with a tax receipt and a proof of permanent residence in hand to apply for a library card. The closest branch is at 109 W. Moore Street in Southport (near the intersection of Howe and Moore streets).
- 2. Once you have a card, log onto the online catalog and select the 'Margaret and Jim Harper, Jr.' Branch in the upper right-hand corner of the page. Search for and select the book you want to read then click the 'Place Hold' button.
- 3. Call the branch at 910-457-6237 and ask the librarian to set your selection aside for the Bald Head Island Library Run. Your book will be available for pick up at the Association Center (111 Lighthouse Wynd) after 2:30pm the following Wednesday.
- 4. When you're finished reading the book, just drop it off at the Association Center and it will be returned to the library for you on the next Wednesday run.

Summer Safety Tips

Golf Cart Safety

You must have a valid driver's license to operate a golf cart on Bald Head Island. There are numerous injuries each year as a result from golf cart related incidents. There have been several fatalities from individuals falling off golf carts. To put things in perspective; it is no different than driving your car or truck 18 mph down a road near your home and then opening your car door and falling out onto the roadway. Fractured bones, soft tissue injuries, and head injuries are common injuries from this type of incident.

The majority of the golf cart related injuries on Bald Head Island are a result from an occupant falling out of the cart. They start and stop very abruptly and turn very sharply. It is difficult for passengers, especially rear-facing passengers, to anticipate turns and changes in speed. Ensure that passengers are holding on to the grab rails or other solid surface on the cart before performing any sudden movements. Children should not be in the lap of the driver, as they can impede the driver's ability to maneuver the golf cart. Packages should be secured to the cart, not held by passengers. Again, passenger's hands should be free to hold onto the grab rails. Whenever possible, use hand signals when turning or stopping. This will aid others in knowing your intentions. Please remember golf carts are not toys and enjoy you visit to Bald Head Island.

Think of the same laws when you drive your car on the mainland. Violation of laws or ordinances will result in law enforcement action, up to and including going to jail. Here are just a few of the

laws and ordinances designed to keep you safe while enjoying your time on the Island:

- Open alcoholic beverage containers are prohibited in golf carts.
- The speed limit is enforced (18 mph).
- Careless or reckless driving is prohibited.
- Driving while intoxicated (alcohol or drugs) is not tolerated.

Bicycles/Scooters

Bicycling across the island can be a wonderful experience. But please remember that the roadways are shared with golf carts, cars and small trucks, and large shipping trucks. The roadways are quaint and edged with vegetation. Please wear your helmet to help protect your head and brain from injury in the event you have an accident. You should also wear brightly colored clothing for higher visibility, both day and night.

Local laws and ordinances *require* anyone under the age of 16 to wear a helmet while on a bicycle, scooter (motorized or non-motorized), roller blades, or similar means of transportation. These rules are in place to reduce the chances and seriousness of potential head and facial injuries.

Wildlife

There is an abundance of wildlife on the island, ranging from small insects to large alligators and deer. Wildlife should be observed from a distance, and not approached or handled. Even the tamest appearing animal can become hostile when it perceives a threat. Sick and injured birds, raccoons, and other animals should be avoided and, if observed, the Public Safety Department should be contacted with approximate location at 457-5252. Please remember that these animals should not be approached or touched.

Animals can also carry rabies or other diseases that can cross over to the human population resulting in sickness and sometimes even death. You should always contact the Public Safety Department to report a sick or injured animal.

Bald Head Island is also home to the American Alligator. The animals should never be approached as they are wild animals.

NEVER feed an alligator for several reasons;

- They may mistake you for food.
- They can become too desensitized to humans, which could result in closer contact with humans and possible attacks.
- A \$500.00 fine will be issued to anyone found feeding or harassing alligators, deer, raccoons, opossums, foxes or otters.

Sea Turtles frequent the shores of Bald Head Island and are a federally protected species. It is unlawful to harass, harm, pursue, hunt, shoot, wound, kill, trap, capture, or collect sea turtle hatchings, eggs or adult turtles. Violating the law regarding this federally protected species can include up to a \$100,000.00 fine and/or up to one (1) year in jail.

Please visit The Conservancy for guided tours to view island wildlife. This is the safest and most preferred method to view wildlife while learning about their lifestyles and history.

Beach/Ocean Safety

The beach and ocean are a wonderful place to relax, bath in the sun, and play games in the sand. However, the ocean is also a very powerful force than can turn a good vacation into a devastating nightmare. Please remember that ocean currents and waves can change rapidly and the threat of dangerous *rip currents* is ever present risk.

Here are a few tips while at the beach:

- Never swim or be on the beach during storms, especially since they pose a lightning risk.
- Pay attention to the number of the Beach Access that you take when traveling to the beach and familiarize yourself with the closest 911
 Emergency Telephone Box- they are located at many of the beach access entrances.

- Apply adequate sunscreen, according to the manufactures directions, to reduce the chance of severe sunburn and risk of skin cancer.
- Alcohols and/or drugs are a bad combination with swimming.
- Always swim with a friend; never swim alone.
- Always stay within a safe distance of the shore.
- Stay alert for jellyfish and other aquatic life.
- Be alert and try to avoid swimming in areas where people are fishing.

Military ordnances occasionally wash up or are uncovered by erosion on our beaches. This includes cannon balls from years past and modern day ordnances. If you see any objects such as these then please call 911 immediately so the Public Safety Department can investigate. DO NOT TOUCH

THEM as they could detonate and injure or kill you.

Stay clear of the sand dunes and the groins (large sandbags that reduce beach erosion). There is a \$500 fine for walking on either of these very important structures.

Fire

Please remember that fires can be catastrophic on an isolated island such as Bald Head. The Village has an *Open Burning Ordinance* that prohibits open fires without a permit issued from Director of Public Safety. Open fires include camp fires, luminaries or other type of fireworks, and any other open flames with the exception of LP gas grills, and other cooking appliances. Please be aware that cooking appliances/grills, other than LP gas, must be at least ten (10) feet away from any building or deck while in use. A \$500.00 fine will be issued to anyone who violates this ordinance.

BHA Board of Directors Encourages BHI Residents to Approve Terminal Groin Funding

At its April 11th meeting, the Bald Head Association's Board of Directors learned the details of the proposed terminal groin from Village of Bald Head Island Assistant Manager and Shoreline Protection Manager Chris McCall.

McCall explained the rationale for the terminal groin's design, including aspects of the staged construction and the benefits expected for South and West Beach through its 'leaky' design. He further discussed the balance long-time coastal engineer Eric Olsen



expects to strike by capturing adequate sand to protect South Beach while simultaneously allowing enough sand to traverse around The Point to reach West Beach.

The proposal is the result of significant planning on the part of the Village's leadership. It is expected that the terminal groin, which will be voted on by BHI residents who are registered voters and paid for by all BHI taxpayers, will save the community millions of dollars over the next three decades.

The BHA Board ultimately voted to encourage registered BHI voters to authorize the Village to sell up to \$18 million in bonds for the BHI terminal groin project. Three primary reasons drove the Board's decision:

1. No new BHI taxes, fees or revenues are needed. Existing revenue streams can be utilized.

- 2. An investment of up to \$18 million is expected to save more than \$30 million over the next three decades.
- 3. Most compellingly, without the terminal groin and revision of the current Sand Management Plan the template that outlines the specifics of where and when sand is dredged and placed by the U.S. Army Corps of Engineers the Island will receive NO sand for at least 4 years and the Village will be obligated to repeat the 2009 beach fill project at a similar cost to the terminal groin.

Don't Feed the Gators (or any of the island's other wildlife!) ~Nicki Dardinger, Director of Conservation, BHI Conservancy

The warmer weather is finally upon us, and with the increased temperatures comes the emergence of the island's reptiles. Yellow-bellied sliders (*Trachemys scripta*) are basking on logs. Black racers (*Coluber constrictor*) and yellow rat snakes (*Elaphe obsoleta quadrivittata*) are moving through the maritime forest, and banded watersnakes are hanging out near the salt marsh. And of course, American alligators (*Alligator mississippiensis*) are swimming in the freshwater ponds and sunning on the shores.

The island is home to several dozen American alligators, a protected species in North Carolina. While these large animals are exciting to see, it is very important that they are left undisturbed, and even more importantly, left unfed. All too often, people will be seen dropping food into the Overlook pond, despite the warning sign. When asked, they will exclaim, "But we're not feeding the alligator – we're feeding the turtles!" Let me assure you, the alligators don't know the difference! (and it's equally important to not feed the turtles!!) Please, leave Bald Head Island's wildlife wild – for their health - and for YOUR safety.
