We would like to take this opportunity to respectfully oppose the proposed ADA project at Lot 1319. We believe it is unnecessary to build such a large and expensive structure that will require persons with disabilities to climb a total of 28 feet to access and return from the beach over 9 feet of dunes. The main purpose of such a project is to help people with disabilities access the beach conveniently and safely. Oftentimes, a person with a disability will have someone assist them but others may have to access the beach under their own power, by using a wheelchair or walker.

In addition, such a large structure will require regular maintenance and may be compromised by severe storm surges. Damage or erosion to the dune under the structure may be very difficult to repair to its original condition.

Alternatively, we believe there is an existing public access point on Peppervine Trail (Access 24B) that is relatively close to Lot 1319 and has more attributes to serve as an ADA access point, such as:

- 1. A wide access trail is already present at this location and would likely require significantly less construction effort, materials, maintenance, and funds to complete the project.
- Much of the existing trail is flat or has a very mild slope and would only need to clear a few (2-4) feet of the dune. Such a minimal slope would make access much easier and safer and require less maintenance.
- 3. There is already a low-lying, large gap at the dune location where disabled persons would access the beach, thus requiring very little if any disturbance of the dune.

Regarding the proposal to create parking for 20 carts, we would ask that you consider a smaller parking area to be more consistent with other less-obtrusive public access areas.
