## COVID-19 UPDATE

### Transportation Changes Effective Tomorrow (April 1, 2020)

During its Emergency Meeting on Saturday, March 28, 2020, the Village of Bald Head Island Council requested that Bald Head Island Transportation approach the Utilities Commission about the modified ferry schedule and emergency policies that were supposed to go into effect at 5:00 p.m. yesterday as a result of Governor Cooper's [stay-at-home order](#).

Yesterday, Bald Head Island Transportation submitted a "motion for extension of time to implement modified ferry schedule and emergency policies." Click [HERE](#) to view the cover letter and motion. **REMINDER: Second-Home Property Owners Should Still Stay at Primary Home**

As a reminder, the Village still strongly recommends that second-home property owners not travel to Bald Head Island until travel guidance and other travel orders are lifted. Considering the State of North Carolina’s stay-at-home orders and those of numerous states and local governments, non-essential travel to BHI is not allowed.
