Dear Members of the Local Government Commission:

We are Bald Head Island residents and property owners who are deeply concerned about the delays and continuing uncertainty regarding the purchase of the Bald Head Island transportation system by the Authority. We do not share the views of the Mayor and Council, a majority of whom are up for election in November. We do not believe their assertion that a majority of ferry users support the Village's acquisition; it is far more likely that a majority of islanders and ferry users do not care who runs the system as long as it is run well, and prices do not increase faster than inflation. We do know that a substantial number of island residents *oppose* acquisition by the Village, particularly if it would increase our general obligation bond debt.

We believe the delay has affected employees, ferry operations, and crucial planning decisions and is likely to result in higher bond interest rates and investor uncertainty. However, our greatest concern is that, if the sale to the Authority is delayed further or scuttled, Bald Head Island Limited will sell the system, in whole or as separate lines of business, to for-profit entities: as is Limited's right. Unlike the island's developer, these for-profit owners would have little interest in keeping fares low. Indeed, since the parking and barge operations have features of unregulated monopolies, there is every reason to expect that a new owner, facing little or no threat of competition and controlling the only barge and ferry services to the island, would raise fares significantly to maximize profits. Third party ownership would be the very worst outcome for our island.

We fully understand the concerns members of the Commission have about the valuation of the system's assets. We understand that a new independent appraisal will be available before the August meeting of the Commission that is expected to address many of the Commission's concerns. We strongly encourage that the Commission to act on the bond proposal at the August 3 meeting rather than prolonging the process.

As you know, the Village has belatedly decided to try to purchase the system. Even if the Village has a valid right of first refusal (which we gather is not clear) and could convince BHI Limited to sell the system to the Village (which we believe is unlikely), we do not believe the Village should operate the transportation system. We are skeptical about the Village's capacity to operate a transportation system; we question the Village's ability to operate in the best interest of all transportation system users (the vast majority of whom are not residents of the island); and we doubt that the Village voters would approve a GO bond referendum (for \$52.5 million) that would more than quintuple the Village's general obligation debt. In addition, we are concerned that fewer than 300 voting property owners would be making a decision on the potential debt for the 2000 property owners of Bald Head Island.

Please base your decision on the feasibility and affordability of the Authority's bond proposal, ignoring irrelevant speculation about alternative owners. We urge you to proceed expeditiously with the sale of the transportation system to the BHITA.
