Good morning. I am writing as a 20-year-long real property owner on Bald Head Island, to express my views on the issue of who will acquire the transportation system for BHI. My husband and I have owned three different homes on the island, including one rental property that I managed myself for 20 years. We purchased a retirement home on the island last fall, and spend several months a year here, with plans to increase that time commitment in the coming years.

I am opposed to the acquisition of the transportation system by the Village of BHI for two primary reasons. First of all, I oppose the issuance of general obligation bonds to support the purchase, and far prefer the method of financing proposed by the BHITA established by the State of NC, that is, with bonds repaid thru ferry revenues. Secondly, I prefer a broader representation on the board of the ownership entity, and welcome the leadership voice and perspectives of the County of Brunswick and the town of Southport. They both have a strong vested economic interest in maintaining property values on this island, nurturing the rental market and local businesses on the island, and supporting the needs of the hundreds of Brunswick county residents who try to make a living on this island and who are vital to the economic success of the island. The Village Council is elected by a couple of hundred full time residents, who (in my experience) mostly tend to have a very narrow perspective on a variety of island issues. I respect the Village Council members and understand that they have been working very hard on this issue and that reasonable minds can differ, and I know they try to have the best interests of all parties in mind as they make decisions, but the fact remains that their constituent base is a tiny fraction of the truly interested parties. The state of NC successfully runs other ferry systems and I trust them to do a good job with this one as well, thru the BHITA.

Ladies and Gentlemen,

My wife and I are owners of a second home at Bald Head Island. I write to support the bond financing that will be required by the Village of Bald Head Island to purchase the Transportation System, even though such a purchase could conceivably require increases in property taxes at some point.

My reasoning for preferring this option (as opposed to BHITA being the purchaser via its own bond financing) is as follows: First, I believe that the more local the governance the better, in most instances. Second, the Village and island residents are the beneficiaries (and bear the direct and indirect costs) of tourism and vacation rentals on the island; they are in the best position to evaluate long-term whether operational costs should be borne primarily by ticket purchasers (which includes non-property owners) vs. being borne in whole or in part by increased taxation, much of which is passed on to visitors through increased rental fees. In addition, there is already substantial cost to developers, families building new residences, and various trades in traveling to and from the island. Let the voters of BHI and the Village Counsel be in charge of gauging how to fund transportation in light of the balance between development and preservation that islanders must strike.


Finally, I am blessed that my work life these many years permitted our family to have what is frankly a very exclusive second-home and tourism experience. I must be objective and admit that it isn't fair that hard-working taxpayers in poorer sections of the State should be responsible for bond financing or taxes related to Bald Head Island.

No, I don't like paying increased taxes, or increased parking and ferry fees for that matter. There ain't no free lunch—and shouldn't be for owners of million dollar homes. And it's my rear that has to experience the pain of rickety trams that need replacing. I don't always agree with Village Council votes, but the couple hundred voters in this little island community are much better positioned to keep a careful eye on the Village Council's decision making as opposed to trying to track BHIITA activity.

But regardless of which appraisal forms the basis of a purchase price, I am confident that local control is better for the Village as well as the State in this situation.
